# **Project Executive Summary**

#### Cost

After meeting with you and reviewing your current site, I would estimate your site would cost approximately \$2,000. This estimate is derived from the three attached line-item estimates. These are labeled HEV-1 which consists of domain registration, email setup and hosting via Google Apps for Work, and my standard hosting plan; HEV-2 consists of the additional software/plugins that would be needed to accomplish your business needs; and HEV-3 consists of the actual development billable time.

### Project Approach

Provide a world-class website and user experience for both desktop, tablet and mobile users, beginning with content from current website (if available) presented in a newly customized WordPress template that is **responsive** for desktop, tablet and mobile devices. Your menu structure would be kept approximately the same. Your website would be interactive allowing social sharing to social networks Facebook and Twitter and other social media sites that meet your needs. Website traffic usage would be tracked using the industry standard, Google Analytics and Search Engine Optimization would be done using the All-in-One SEO Service using your provided content to optimize searches. Website security would be controlled via iTheme Security and Sucuri Security plugins.

We would develop your site on a new temporary domain, for example: <u>eastvillagedesmoines.us</u> or <u>eastvillagedsm.com</u> which would allow you to see the site and have yourself and others to preview the content prior to switching over to your domain of <u>eastvillagedesmoines.com</u>
